WHAT IS ENDURAFLECT®?:

Enduraflect® is our reflective prismatic vinyl material ideal for a variety of applications where high visibility is required. Typical usage includes street signs, trail and wayfinding signage. Available in a variety of base colors and prismatic grades including Engineering Grade, High Intensity and Diamond Grade.

CLEANING INSTRUCTIONS FOR ENDURAFLECT®:

Enduraflect® reflective faces can be cleaned when defaced with most common graffiti materials. Cleaning is accomplished through the use of a mild graffiti cleaning solvent and should be tested on an inconspicuous area prior to complete treatment.

Generously apply solvent to the entire defaced area. Allow the solvent to set on the material for a period of one minute. Using a non-abrasive paper towel wipe the solvent and graffiti from the affected area. A non-abrasive nylon scouring pad may also be used. If necessary, re-apply the solvent for a period of two minutes on heavily affected areas. Remove with a paper towel then nylon nonabrasive scouring pad. When finished use a paper towel & water to solvent residue with water. The Enduraflect® reflective printed face is resistant to most common solvents. When tested according to LS-300C, Section 3.6.2, immersion in the following solvents for the specified length of time the top film shows no deterioration:

Kerosene -10 minutes

Turpentine -10 minutes

Toluene -1 minute

Xylene –1 minute

Methyl Alcohol -1 minute

MAINTENANCE:

Enduraflect® signs are relatively maintenance-free due to the durability of these signs. However, an occasional washing with mild soap and water will help retain the original color and vivid graphics on the sign.

WARRANTY FOR OUTDOOR SIGNS:

Gopher Sign Company warrants to the buyer that an image will retain its usefulness as an informational sign when vertically mounted for a period of 10 years from the date of manufacture for ASTM D-4956 Type XI & Type III retro-reflective faces and 7 years for Type I.
